## **Supporting Documents to be submitted**

- 1. A letter addressed to the Head, Immigration Support Services, Ministry of Home Affairs, requesting Business Visa (Extension of Stay/Work Permit) for business person. A brief history of the business is to be included.
- 2. Copy of Business Registration.
- 3. Copy of Income Tax Liability Statement and NIS Compliance Return.
- 4. Copy of the applicant's entire passport which should include all entry stamps.
- 5. Police Clearance and Medical of applicant.

## **IMPORTANT**

- Extension of stay will be granted for a period of two (2) years.
- Processing fee \$28,700 (US\$140) for each extension, payable in cash or Manager's cheque.
- Failure to submit <u>ALL</u> supporting documents will affect processing of application.
- The estimated processing time for application is one (1) month.
