Applicants are required to submit two (2) recent passport size photographs along with the following documents to facilitate processing of the application:-

### **DOCUMENTS REQUIRED**

- 1. A copy of the Certificate of Vehicle Registration and the Certificate of Fitness in respect of which the application for tint waiver is made.
- 2. A copy of the last tint permit received (if applicable).
- 3. The above mentioned Original Documents for verification.

#### APPLICATION PROCESS FOR A TINT WAIVER

The process from application to final approval or rejection for a tint waiver is as follows:

- 1. Upon receipt of the application, along with documents required, the applicant will be served with a letter that must be taken to the Licence Revenue Office (LRO) in order to verify the Vehicle's Tint Density.
- 2. Subsequent to the completion of this verification process, the Licence Revenue Office (LRO) will submit its Tint Reading to the Minister of Home Affairs for his approval/refusal.
- 3. The Ministry will notify the applicant of the final decision, and if the application is approved, the applicant will be granted a TINT WAIVER PERMIT.

#### IMPORTANT

- 1. Tint Waiver Permits are valid for six (6) months and should be renewed at least one (1) week before the expiry date.
- 2. The estimated processing time for an application is three (3) to five (5) working days.
- 3. Only vehicles with a MANUFACTURE'S TINT are eligible to be considered for a Tint Waiver.
